The RELEASEES do not provide any warranty of fitness or any other warranty or representation with respect to the condition or safety of any (a) equipment, tools, firearms, knives, axes, saws, archery equipment, climbing equipment, slingshots, boat(s) or vehicle(s) used for transportation of any kind (including to and from events and activities); (b) any other equipment used in any events or activities; or (c) the condition of the accommodations, buildings, fixtures, premises, facilities, land or other properties where activities occur.
- 2.
